BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

"AN ORDINANCE TO AMEND THE 2023 GARLAND COUNTY BUDGET ORDINANCE O-22-57; TO APPROPRIATE FUNDS, AND CREATE A NEW PART-TIME POSITION, THEREFORE TO THE VETERANS SERVICE BUDGET; AND, FOR OTHER PURPOSES."
