RESOLUTION NO. R-20-30

BE IT RESOLVED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, A RESOLUTION TO BE ENTITLED:

“A RESOLUTION OF THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS SELECTING A MEMBER TO FILL A VACANCY ON THE GARLAND COUNTY EQUALIZATION BOARD.”

WHEREAS, Arkansas code 26-27-304 and 26-27-305, establish a procedure for appointing members and filling vacancies to county equalization boards, including that two (2) members shall be appointed by majority vote of the quorum court, and

WHEREAS, the referenced statutes require at such time there is a vacancy on the equalization board, it shall be filled by the entity that originally selected the member, and

WHEREAS, TOM BRYANT was originally appointed to Garland County Equalization Board by the Garland County Quorum Court, and

WHEREAS, TOM BRYANT has retired and resigned from the Garland County Equalization Board, effective July 16, 2020, and

WHEREAS, The Garland County Quorum Court has selected LARRY GRIFFIN to fill the vacant seat and serve the unexpired term, and his term shall expire on the first Monday in June, 2022.

NOW THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That LARRY GRIFFIN, a duly qualified elector and real property owner in this county is hereby appointed to the Garland County Equalization Board for a term ending on the first Monday in June of 2022.
