**ORDINANCE NO. O-21-29**

**BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:**

**"AN ORDINANCE AUTHORIZING THE COUNTY, BY AND THROUGH THE COUNTY JUDGE, TO PURCHASE PROPERTY AT 538 WEST GRAND AVENUE, HOT SPRINGS, ARKANSAS ON BEHALF OF THE COUNTY; AND FOR OTHER PURPOSES."**

**WHEREAS**, the Garland County Quorum Court has determined that the purchase of the property at 538 West Grand Avenue in Hot Springs, Arkansas is in the best interest of Garland County and its citizens; and,

**WHEREAS**, the Garland County Quorum Court authorizes the Garland County Judge to make this purchase on behalf of the County; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That the Quorum Court of Garland County, Arkansas hereby declares that it is in the best interest of the County to purchase the property at 538 West Grand Avenue in Hot Springs, Arkansas herein, and so authorizes.

**SECTION 2.** As time is of the essence in making this purchase, an **emergency** is hereby declared to exist, and this Ordinance shall be in full force and effect from and after its passage and approval.
