MINUTES FOR THE SPECIAL MEETING ON JUNE 25, 2018.

A special meeting of the Garland County Quorum Court was held on June 25, 2018 at 6:00 P.M. at Hot Springs, Arkansas with Judge Rick Davis presiding.

Opening prayer was led by Justice Thomas Anderson

A motion was made by Justice McKee to approve the Agenda, duly seconded by Justice Horner. Motion Carried

Judge Davis declared the Public Hearing, on the filing of a lien for the costs of emergency abatement at 117/126 Arcade Street, was now open.

Judge Davis announced that the floor was now open for preliminary comments: Shelly Waddle gave a presentation on 117 Arcade Street.


