Chairman Owen called the meeting to order and introduced Resolution R-19-15 which was a Resolution of the Quorum Court of Garland County, Arkansas authorizing the Garland County Judge to apply for a matching grant to repair and resurface a portion of Blacksnake Road. A motion was made by Justice Reagan, seconded by Justice Young to approve R-19-15. The motion carried without opposition.

Chairman Owen introduced Resolution R-19-16 which was a Resolution of the Quorum Court of Garland County, Arkansas authorizing the Garland County Sheriff to apply for a grant on behalf of the Sheriff's Department (Edward Byrne Memorial Justice Assistance Grant-JAG). A motion was made by Justice McGrew, seconded by Justice Dixon to approve O-19-16. The motion carried without opposition.

Chairman Owen introduced Resolution R-19-17 which was a Resolution of the Quorum Court of Garland County, Arkansas authorizing the Garland County Sheriff to apply for a matching grant on behalf of the Sheriff's Department (Selective Traffic Enforcement Program-STEP grant). A motion was made by Justice Young, seconded by Justice McGrew to approve R-19-17. The motion carried without opposition.

Chairman Owen introduced Resolution R-19-18 which was a Resolution of the Quorum Court of Garland County, Arkansas authorizing the Garland County Prosecuting Attorney to apply for a matching grant on behalf of the Prosecuting Attorney's Office (Victim of Crimes Act-VOCA grant). A motion was made by Justice Dixon, seconded by Justice McGrew to approve R-19-18. The motion carried without opposition.

Chairman Owen introduced Ordinance O-19-35 regarding setting an election within the 70 West Fire Protection District to elect members of the Board of Commissioners for such fire protection district at a public meeting on Monday, November 4, 2019. Chairman Owen stated an Emergency Clause had been added to the Ordinance and the corrected Ordinance would be provided at the Quorum Court meeting. A motion was made by Justice McGrew, seconded by Justice Dixon to approve O-19-35. The motion carried without opposition.

Chairman Owen introduced Ordinance O-19-36 authorizing the County, by and through the County Judge, to continue to do business with McGrew Electric, Inc. A motion was made by Justice Young, seconded by Justice Hunter to approve O-19-36. The motion carried without opposition with Justice McGrew abstaining.

Chairman Owen introduced Ordinance O-19-37 amending the 2019 Garland County Budget Ordinance O-18-56; anticipate revenue, and to appropriate funds to various budgets. A motion was made by Justice Young, seconded by Justice Reagan to approve O-19-37. The motion carried without opposition.

Chairman Owen introduced Ordinance O-19-38 amending the 2019 Garland County Budget Ordinance O-18-56; anticipate revenue, and to appropriate funds to the Juvenile Detention and Prosecuting Attorney budgets. A motion was made by Justice Reagan, seconded by Justice McGrew to approve O-19-38. The motion carried without opposition.

With no further business the meeting adjourned.
