

**APPROPRIATION ORDINANCE NO. O-19-08**

**BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED:**

**“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; TO PROJECT REVENUES, AND TO APPROPRIATE FUNDS FROM THE TAX COLLECTOR’S BUDGET AND THE SHERIFF’S BUDGET; AND FOR OTHER PURPOSES.”**

**WHEREAS**, the Tax Collector and the Sheriff requested the creation of the position of Bailiff for the Garland County Government Building; and,

**WHEREAS**, the Tax Collector requested an appropriation of \$15,641 in the Collector’s Automation Fund, Tax Collector’s Budget and a transfer of \$44,000 within the same fund to pay the General Fund \$59,641 to fund the new position and purchase two portable radios; and,

**WHEREAS**, the Sheriff requested an appropriation of \$59,641 for the new position and two portable radios in the General Fund, Sheriff’s Budget; and,

**WHEREAS**, the Human Resources and Finance Committees previously met and approved the position request; and,

**WHEREAS**, the Finance Committee has also approved the equipment appropriation requested.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That the sum of \$15,641 is hereby appropriated from the Collector’s Automation Fund to the Tax Collector’s Budget in the following manner:

**SECTION 2.** That the sum of \$44,000 is hereby transferred within the Collector’s Automation Fund, Tax Collector’s Budget line items in the following manner:

**SECTION 3.** That the Anticipated Revenues for the General Fund are \$59,641 and the Quorum Court may appropriate 100% of these revenues to the Sheriff’s Budget:

**SECTION 4.** That the position of Bailiff – Government Office Building is hereby created. PCN#1000.0400.0593 will be assigned to this position.

**SECTION 5.** That the sum mentioned in Section 1 and Section 2 has no effect on the Collector's Automation Fund Anticipated Revenues.

**SECTION 6.** That the sum mentioned in Section 1 represents an increase of \$15,641 in the Collector's Automation Fund, Tax Collector's Budget.

**SECTION 7.** That the sum mentioned in Section 2 has no effect on the Collector's Automation Fund, Tax Collector's Budget.

**SECTION 8.** That the sum mentioned in Section 3 represents an increase of \$59,641 in the General Fund Anticipated Revenues.


**SECTION 9.** That the sum mentioned in Section 3 represents an increase of \$59,641 in the General Fund, Sheriff's Budget.

**SECTION 10.** That the County Treasurer and the County Judge are hereby authorized to execute the transfer as follows:
