

APPROPRIATION ORDINANCE NO. O-20-16

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2020 GARLAND COUNTY BUDGET ORDINANCE O-19-54; TO ANTICIPATE REVENUE, AND APPROPRIATE FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”

WHEREAS, the Sheriff deposited \$9,188.87 with the County Treasurer in the General Fund for various reasons and would like \$2,081.73 appropriated in the Sheriff’s Budget and \$7,107.14 appropriated in the Juvenile Detention Budget; and,

WHEREAS, the Sheriff deposited \$27,066.00 with the County Treasurer in the Boating Safety Fund for donations and would like it appropriated in the Sheriff’s Budget; and,

WHEREAS, the Sheriff deposited \$7,208.80 with the County Treasurer in the Detention Facility Fund for an insurance claim, extradition, and cancellation of a conference reimbursement, which he would like to appropriate in the County Jail Budget; and,

WHEREAS, the Sheriff deposited \$173.17 with the County Treasurer in the Commissary Sales Fund from inmate reimbursements on property damage, and he would like it appropriated in the Sheriff’s Budget; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That Anticipated Revenues for the General Fund are \$9,188.87, and the Quorum Court may appropriate \$2,081.73 to the Sheriff’s Budget and \$7,107.14 to the Juvenile Detention Budget.

SECTION 9. That the sum mentioned in Section 2 represents an increase of \$27,066.00 to the Sheriff's Budget.

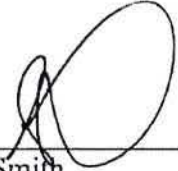
SECTION 10. That the sum mentioned in Section 3 represents an increase of \$7,208.80 to the Detention Facility Fund Anticipated Revenues.

SECTION 11. That the sum mentioned in Section 3 represents a increase of \$7,208.80 to the County Jail Budget.

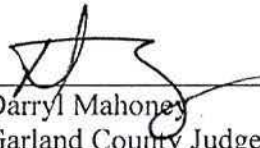
SECTION 12. That the sum mentioned in Section 4 represents an increase of \$173.17 in the Commissary Sales Fund Anticipated Revenues.

SECTION 13. That the sum mentioned in Section 4 represents an increase of \$173.17 to the Sheriff's Budget.

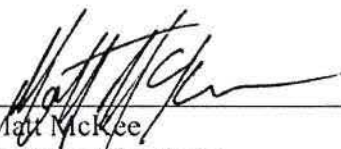
