

APPROPRIATION ORDINANCE NO. O-20-23

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2020 GARLAND COUNTY BUDGET ORDINANCE O-19-54; TO ANTICIPATE REVENUE, AND APPROPRIATE FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”

WHEREAS, the County Judge deposited \$8,901.97 with the County Treasurer in the County Road Fund for reimbursement on sales tax paid by the county for chip sold and would like to appropriate these proceeds in the County Road Budget; and,

WHEREAS, the County Judge deposited \$4,380.00 with the County Treasurer in the Solid Waste Fund for the sale of a compactor and would like to appropriate these proceeds in the Solid Waste Budget; and,

WHEREAS, the Tax Collector deposited \$3,481.63 with the County Treasurer in the Collector’s Automation Fund for a refund of postage and would like to appropriate these proceeds in the Tax Collector’s Budget; and,

WHEREAS, the Sheriff requests an appropriation of \$97,984.00 in the General Fund, Sheriff’s Budget to purchase two patrol vehicles and the outfitting for both; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That Anticipated Revenues for the County Road Fund are \$8,901.97, and the Quorum Court may appropriate these proceeds to the County Road Budget.

SECTION 2. That Anticipated Revenues for the Solid Waste Fund are \$4,380.00 and the Quorum Court may appropriate these proceeds to the Solid Waste Budget.

SECTION 3. That Anticipated Revenues for the Collector’s Automation Fund are \$3,481.63, and the Quorum Court may appropriate these funds to the Tax Collector’s Budget.

SECTION 4. That sum of \$97,984.00, is hereby appropriated from the County General to the Sheriff’s Budget.

SECTION 5. That the sum mentioned in Section 1 represents an increase of \$8,901.97 in the County Road Fund Anticipated Revenues.

SECTION 6. That the sum mentioned in Section 1 represents an increase of \$8,901.97 to the County Road Budget.

SECTION 7. That the sum mentioned in Section 2 represents an increase of \$4,380.00 in the Solid Waste Fund Anticipated Revenues.

SECTION 8. That the sum mentioned in Section 2 represents an increase of \$4,380.00 to the Solid Waste Budget.

SECTION 9. That the sum mentioned in Section 3 represents an increase of \$3,481.63 to the Collector's Automation Fund Anticipated Revenues.


SECTION 10. That the sum mentioned in Section 3 represents an increase of \$3,481.63 to the Tax Collector's Budget.

SECTION 11. That the sum mentioned in Section 4 has no effect on the General Fund Anticipated Revenues.

SECTION 12. That the sum mentioned in Section 4 represents an increase of \$97,984.00 to the Sheriff's Budget.
