

**APPROPRIATION ORDINANCE NO. O-20-29**

**BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:**

**“AN ORDINANCE TO AMEND THE 2020 GARLAND COUNTY BUDGET ORDINANCE O-19-54; TO ANTICIPATE REVENUE, AND APPROPRIATE FUNDS THEREFORE TO SOLID WASTE AND JUVENILE DETENTION BUDGETS; AND, FOR OTHER PURPOSES.”**

**WHEREAS**, the County Judge deposited \$22,167.24 with the County Treasurer in the Solid Waste Fund for reimbursements received for the County Clean-up and a grant reimbursement both from Southwest Central Regional Solid Waste. He would like the funds appropriated in the Solid Waste Budget; and,

**WHEREAS**, the Sheriff deposited \$28,574.00 with the County Treasurer in the Juvenile Grant-In-Aid Fund for a grant and would like the funds appropriated in the Juvenile Detention Budget; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That Anticipated Revenues for the Solid Waste Fund are \$22,167.24, and the Quorum Court may appropriate these funds to the Solid Waste Budget.


